Annual Funds

The Georgia Bulldog Club is the fundraising arm of the Athletic Association charged with providing student-athlete scholarships, first-class facilities and the financial support necessary for each of UGA's 21 varsity sport programs.

As a member of The Georgia Bulldog Club your commitment to Georgia Athletics is the lifeblood of our athletic program. The Athletic Association receives no federal,

state or university funding; therefore it relies on the annual contributions from alumni and friends to provide our deserving student-athletes with the necessary academic and athletic tools to compete among the nation's best.

Within The Georgia Bulldog Club there are three annual funds that correspond to the priority seating system for football, men's basketball and gymnastics.

The William C. Hartman Jr. Fund is the priority seating system for the sport of football. Contributions to the Hartman Fund provide student-athlete scholarship support, funding for building and maintaining facilities as well as funding for UGA's 21 varsity sport programs.

The Hartman Fund rewards a contributor's loyalty through the opportunity to purchase renewable season tickets, single game tickets, away game tickets, SEC Championship tickets and Bowl Game tickets. All gifts designated to this fund are 80% tax deductible, separate from the cost of season tickets and allow donor benefits such as preferred parking based on annual donation.

The Basketball Enhancement Fund is the priority seating system for the sport of men's basketball. The Basketball Enhancement Fund was established with the sole purpose of funding facility improvements to Stegeman Coliseum such as the Coliseum Training Facility.

With a per seat annual donation, BEF contributors are given first priority in location of their renewable season tickets based on the priority point system. The Basketball Enhancement Fund rewards a contributor's loyalty by providing the opportunity to retain the same seat location upon renewal each year or request relocation. BEF contributions are 80% tax deductible, separate from the cost of season tickets and allow donor benefits such as preferred parking based on annual donation.

The Gymnastics Endowment Fund is the priority seating system for the sport of gymnastics. Contributions to the Gymnastics Endowment Fund provide student-athlete scholarship support as well as financial support for Stegeman Coliseum facility enhancements such as the Coliseum Training Facility.

With a per seat annual donation, GEF contributors are given first priority in location of their renewable season tickets based on the priority point system. The Gymnastics Endowment Fund rewards a contributor's loyalty by providing the opportunity to retain the same seat location upon renewal each year or request relocation. GEF contributions are 80% tax deductible, separate from the cost of season tickets and allow donor benefits such as preferred parking based on annual donation.

CORPORATE MATCHING GIFTS

Take advantage of your corporation's charitable giving to increase your annual gift and priority points. Obtain a matching gifts form from your human resources office, complete the employee section of the form and submit it with your contribution to The Georgia Bulldog Club. The Georgia Bulldog Club will complete the charitable section of the form and submit it to your corporation. Corporations participating in a matching gifts program will make a donation, in your name, to one of the three annual funds.

STOCK

Donors may make a charitable contribution through an electronic transfer of stock or the actual stock certificate. Donors receive a tax deduction on a gift of stock based on the value of the stock on the day it was received by The Georgia Bulldog Club.

- ✓ Gifts to The Georgia Bulldog Club are 80% tax deductible.
- ✓ Go paperless. Patrons who provide their email address will receive their tax receipt via email. All other patrons will receive a hard copy in the mail.

BENEFITS GLOSSARY:

Opportunity to purchase single home game, away game and post season tickets: Refer to the single home & away game ticket charts on page 11 & 12 for specific game and order opportunities which are based on availability, annual gift and cumulative score. SEC Championship (only if UGA participates) and Bowl Game tickets are assigned based on availability and cumulative score.

Tax Deduction: Donations associated with the purchase of tickets are 80% tax deductible. Contributions not associated with ticket priority are 100% tax deductible. Patrons who provide an email address will receive their tax receipt via email.

Invitations to Meetings and Outings: Receive notification of events such as the Dawg Days Road Tour where you can listen to UGA Coaches talk about the upcoming season.


E-Newsletter: Stay up to date and informed as well as receive special offers through a newsletter emailed to you.

Opportunity to receive home football parking: Parking is assigned based on cumulative score and availability. Any parking requests should be made on the season ticket application. There is no additional cost to obtain a parking pass. You must be a season ticket holder and contributor at the \$2,500 level on the same account to qualify.

Opportunity to receive Georgia/Florida parking: A limited number of donor parking is available at Jacksonville Municipal Stadium in Jacksonville. You must be a Hartman Fund donor at a minimum of the \$5,000 level and receive Georgia/Florida game tickets through the Athletic Association, to qualify. Parking is assigned based on cumulative score and availability. The cutoff score to receive Georgia/Florida parking for the 2008 game was 25,400. The cutoff score changes each year based on availability and demand.

Olympic Sports Passes: Present your pass at the ticket window for any 2009-10 home baseball, women's basketball, soccer, softball or tennis competition and you will receive four complimentary game tickets. Not applicable for post season play.

The Georgia Bulldog Club priority point system recognizes and rewards donors who have made a commitment to Georgia Athletics. Contributors to the William C. Hartman Jr. Fund benefit greatly in the area of tickets and parking. The priority point system is the most fair and equitable way to distribute these benefits.



Hartman Fund priority points are calculated from a contributor's lifetime annual giving to the Hartman Fund on the following basis: **One point per dollar given.**

Priority points are separate for the William C. Hartman Jr. Fund, Basketball Enhancement Fund and Gymnastics Endowment Fund. The William C. Hartman Jr. Fund is the membership and ticket priority program for the sport of football. Only gifts to the Hartman Fund build a contributors priority points for any ticketing or parking requests associated with football. **Patrons have until the Hartman Fund deadline of February 15, 2009 to build their priority points for the 2009 season.**

Hartman Fund Priority Points are used by The Georgia Bulldog Club in the following situations:

- ✓ Assignment of new football season tickets
- ✓ Relocation requests of football season tickets
- ✓ Requests for additional football season tickets (max of 8 renewable season tickets per account)
- ✓ Assignment and relocation requests of home football game day parking
- ✓ Assignment of Georgia/Florida game day parking
- ✓ Assignment of single and away game football tickets
- ✓ Assignment of post season tickets including the SEC Championship (when UGA participates) and Bowl Game

What should I know about priority points...

If I held football season tickets last year?

- ✓ You will retain your same seat location upon renewal of your minimum required donation and season ticket payment, regardless of your priority points.
- ✓ Requests for relocation or additional season tickets (max of 8 per account) are based on availability, annual gift and priority points.
- ✓ The opportunity to order as well as assignment of single, away and post season tickets is based on priority points.
- ✓ Priority points are cumulative. Each year you contribute you accumulate points.

If I did not have football season tickets last year?

- ✓ Assignment of new football season tickets is based on priority points. As Sanford Stadium was sold out for the 2008 season and attrition rates are unknown, the priority points necessary to obtain season tickets for the 2009 season can not be pinpointed by the Athletic Association.
- ✓ For the 2007 season, Hartman Fund contributors received new season tickets with a score or 1,991 or higher. For the 2008 season, the cumulative score to receive new season tickets was 10,651. Score requirements change each year based on availability and demand.
- ✓ Contributors who held season tickets the previous year will retain those season tickets upon renewal, regardless of their priority points. Please keep this in mind when referring to the estimated ranks table as a high ranking as a new contributor does not guarantee you will receive season tickets.
- ✓ The opportunity to order, as well as the assignment of single, away and post season tickets is based on priority points. You do not need to be a season ticket holder to qualify for single, away game and post season tickets; only a current year Hartman Fund contributor.
- ✓ Priority points are cumulative. Each year you contribute you accumulate points.
- ✓ If you did not hold 2008 season tickets but are a previous contributor and season ticket holder, you must make a current year contribution to be eligible for 2009 season tickets. A current year contribution will build upon any priority points you previously accumulated. If you qualify for 2009 season tickets, the location will be based on your annual gift, points and availability.

How Do I Get Renewable Season Tickets? (Season tickets which you may retain upon renewal each year)

To be eligible to purchase renewable football season tickets, join The Georgia Bulldog Club by making a donation to the William C. Hartman Jr. Fund (ticket and priority system for the sport of football), **prior to February 15, 2009**. All Hartman Fund contributors will receive a season ticket application in early March.

Season tickets are assigned after the season ticket order deadline of March 31, 2009 based on the following criteria:

- ✓ **Availability** - Sanford Stadium was sold out for the 2008 season. **Not knowing the attrition rates for 2009, we can not project the necessary priority points to obtain season tickets.** As all seats are subject to availability, making a contribution to the Hartman Fund, at any level, does not guarantee you will receive season tickets.
- ✓ **Annual Contribution** - As a first-time contributor we encourage you to make a gift you are comfortable with to build your priority points. While each section in Sanford Stadium has a per seat contribution associated with it, making that contribution does not guarantee you will receive seats in that section. The actual donation to obtain new season tickets may be higher than the per seat contribution listed.
- ✓ **Priority Points** - All Hartman Fund contributors are put in rank order based on their priority points. Relocation requests, assignment of additional seats as well as assignment of new seats are made in rank order. Current season ticket holders will retain their same seats upon renewal, regardless of their priority points.



- 1 Making a contribution does not guarantee you will receive season tickets.** However, each year you contribute you acquire priority points, which will increase your chances of obtaining season tickets the following season. For the 2007 season, Hartman Fund contributors received new season tickets with a score of 1,991 or higher. For the 2008 season, the cumulative score to receive new season tickets was 10,651. Score requirements change each year based on availability and demand.
- 2 Your contribution to the Hartman Fund is a charitable gift to a worthwhile cause in the academic and athletic endeavors of UGA's student-athletes.** As a charitable gift, your contribution is 80% tax deductible. All contributors to the Hartman Fund will receive a season ticket application, regardless of giving level and priority points. **Season ticket payment is due by March 31, 2009, separate from your contribution and does not guarantee you will receive season tickets.** If your priority points do not qualify for season tickets you will be issued a refund check for your season ticket payment in July. **Please note charitable contributions are non-refundable.**
- 3 When considering a gift to the Hartman Fund, examine the annual giving benefits chart, single home game ticket chart and away game ticket chart.** The annual giving chart includes such benefits as home season parking and Georgia/Florida game parking. The opportunity to purchase single and away game tickets is a benefit of being a Hartman Fund contributor. You do not need to be a season ticket holder to qualify for single and away game tickets.

Renewable Season Ticket Holders (Hartman Fund contributors who held 2008 UGA football season tickets)

WILLIAM C. HARTMAN JR. FUND CONTRIBUTION

While renewable season ticket holders have a minimum contribution required to retain their football season tickets, we recommend examining the annual giving benefits chart, single home game and away game ticket chart when considering your gift. In addition, please keep in mind you are giving to a worthwhile cause in that the Athletic Association relies on Hartman Fund contributions to meet the financial needs of nearly 600 student-athletes. **As a charitable gift, your contribution is 80% tax deductible and non-refundable.**

RENEWING SEASON TICKETS

Renewable season tickets have a minimum donation associated with their location and enable donors to keep the same Sanford Stadium seat location each year. **To retain your season tickets, be sure to make your contribution by February 15, 2009 and season ticket payment by March 31, 2009.** Season ticket applications are mailed early March. Season tickets not renewed by the deadline are made available to fulfill relocation as well as new season ticket requests.

RELOCATING SEASON TICKETS

Make seating requests on your football season ticket application, distributed in March. Relocation requests are handled in priority point order. Making a donation above your minimum required, or the minimum donation associated with a section different than your current section, does not guarantee relocation. However, each contribution you make builds your priority points, increasing your chances for relocation.

ADDING SEASON TICKETS

Making a donation for additional season tickets does not guarantee you will receive additional season tickets. However, each contribution you make builds your priority points, increasing your chances of adding seats. Additional season tickets are assigned based on availability and priority points. If we are able to accommodate your request for additional season tickets, their location will be based on availability and priority points and not necessarily adjacent to your current season tickets. You may have a maximum of 8 season tickets on one account, with no more than 4 assigned to Club Level.

DROPPING SEASON TICKETS

If you wish to drop a portion of your season tickets you may reduce your required minimum donation based on the location of the seats you wish to drop. Please make a note on your season ticket application as to which seat location you would like to drop.

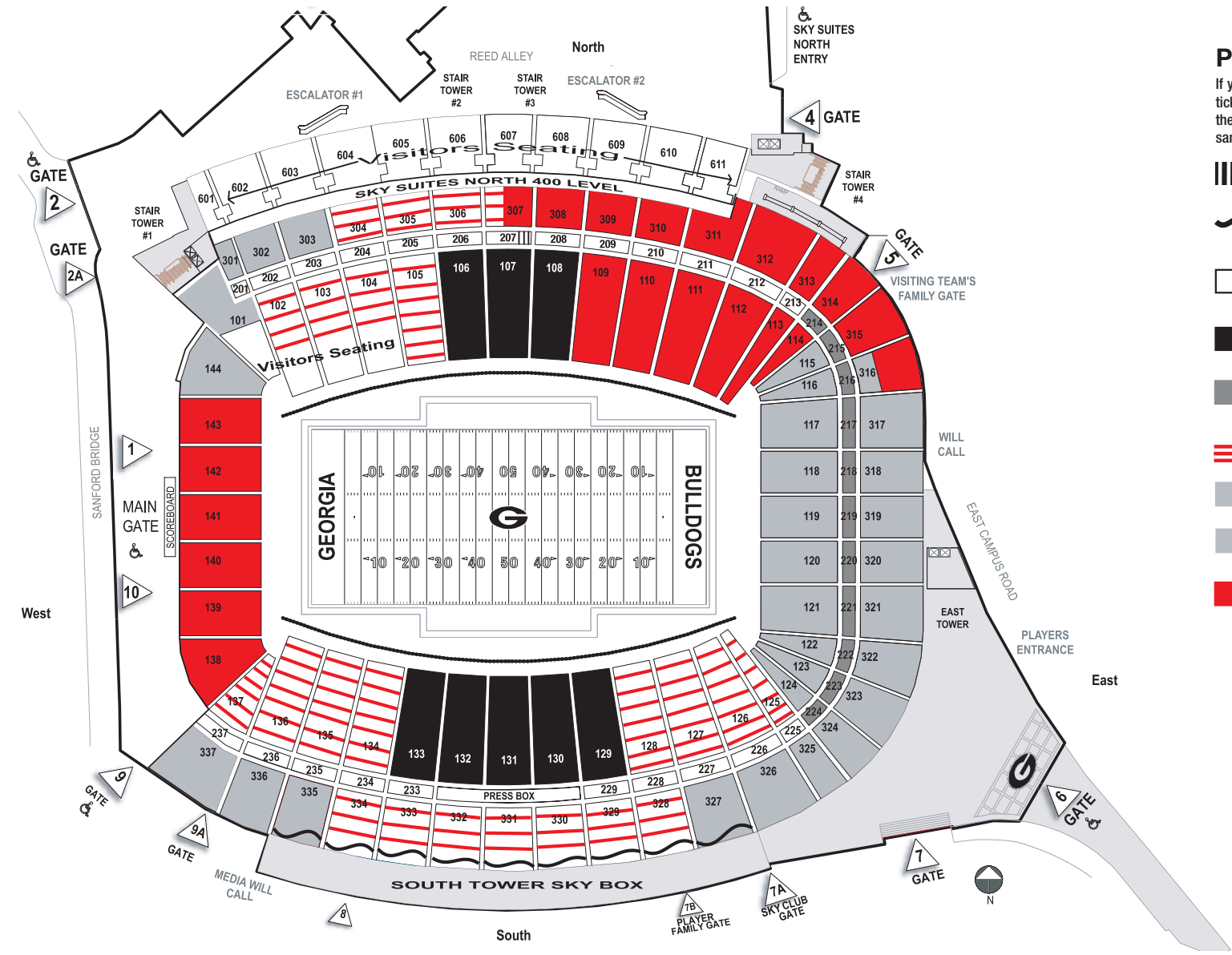
TICKET TRANSFERS

Renewable season tickets can be passed to a spouse at the time of death but can not be passed to another individual, from one priority to another nor can they be willed to a friend or family member. Patrons may not combine multiple accounts.

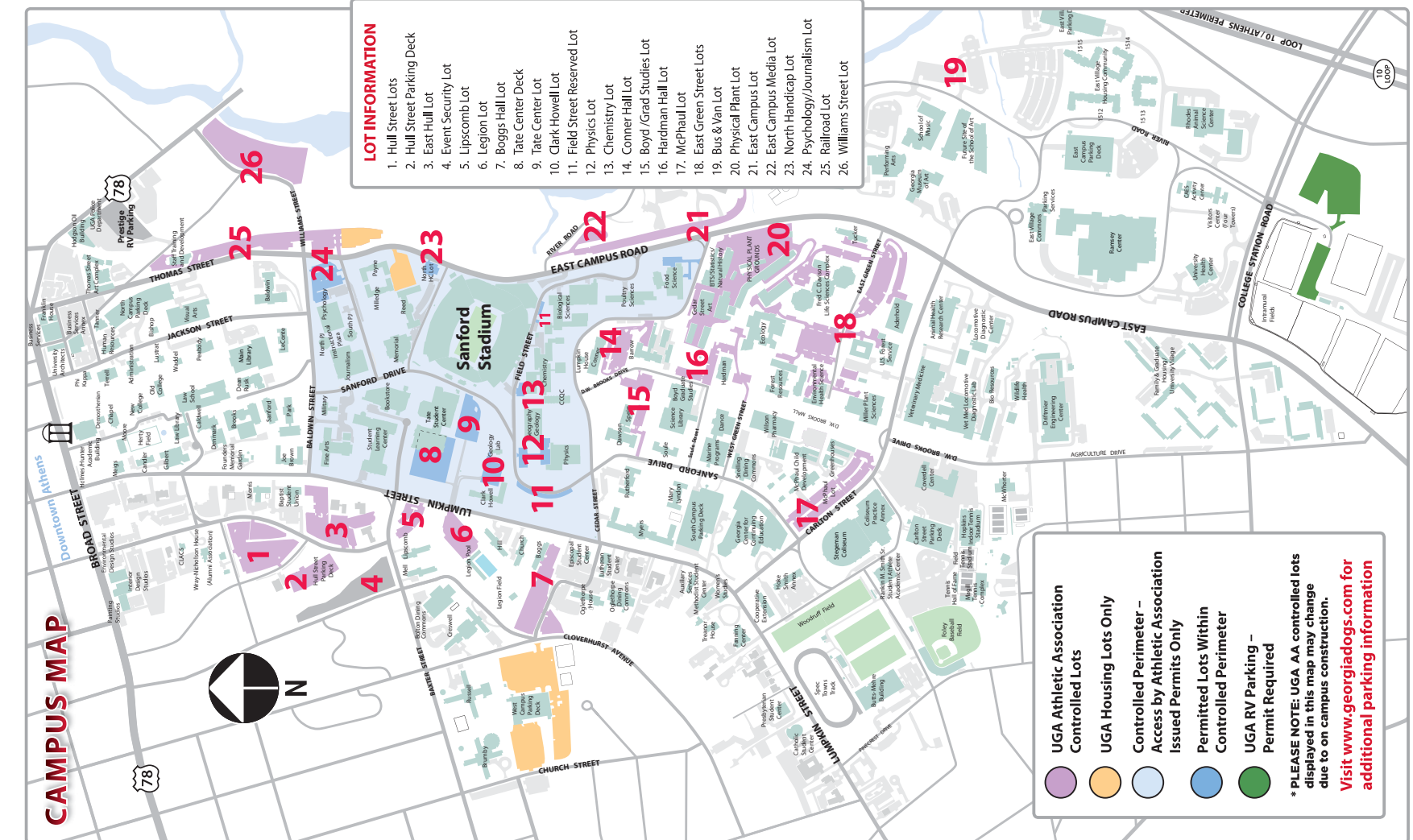

ACQUIRING A SEASON PARKING PASS

You must be a \$2,500 annual donor to the Hartman Fund and receive season tickets through the Athletic Association on the same account, to be eligible for a reserved parking pass from The Georgia Bulldog Club. New parking passes are assigned based on priority points and availability. There is no additional cost for a parking pass and they are distributed USPS with season tickets.

RELOCATING A CURRENT SEASON PARKING PASS

To retain your parking pass you must maintain a minimum contribution level of \$2,500 to the Hartman Fund and your football season tickets through the Athletic Association on the same account. Hartman Fund contributors may request a relocation of their season parking pass on their season ticket application distributed in March. All relocation requests are filled based on availability and priority points.

Single Home Game Tickets

- 1 A benefit of contributing to the Hartman Fund is the opportunity to purchase single home game football tickets. **You do not need to be a season ticket holder to qualify for single home game tickets.** Hartman Fund donors are eligible to order single home game tickets based on their priority points and annual contribution.
- 2 Each game has a cumulative score required to be eligible to order tickets. **This is not a guarantee that anyone within these point totals will receive tickets if ordered.**
- 3 Your Hartman Fund annual donation determines the quantity of tickets you are eligible to order.
- 4 **Single home game tickets are assigned based on cumulative score and availability and cannot be placed next to season tickets. For the 2009 season, ordering single home game tickets or having received them in the past does not guarantee you will receive them.**
- 5 **Payment for single home game tickets must be submitted prior to March 31st.** Payment for single home game tickets does not guarantee you will receive them. Once single home game tickets have been assigned, the Athletic Association will publish the cutoff scores in July. Contributors who ordered single home game tickets but did not qualify, will receive a refund check in the mail for their single home game ticket payment. Contributors who were assigned single home game tickets will receive them in the mail, prior to the start of the season, separate from season tickets.

Auburn/South Carolina: There are no single home game tickets available.

Arizona State, Tennessee Tech: There is no reference available for these games.

LSU: Due to the infrequency of this game and constant change in cumulative scores, the previous cutoff score is not an effective numerical reference.

Kentucky 2007: All Hartman Fund donors who ordered tickets received them.

Away Game Tickets

- 1 A benefit of contributing to the Hartman Fund is the opportunity to purchase away game football tickets. **You do not need to be a season ticket holder to qualify for away game tickets.** Hartman Fund donors are eligible to order away game tickets based on their priority points and annual contribution.
- 2 Each away game has a cumulative score required to be eligible to order tickets. **This is not a guarantee that anyone within these point totals will receive tickets if ordered.**
- 3 Your Hartman Fund annual donation determines the quantity of away game tickets you are eligible to order.
- 4 Away game tickets are assigned based on cumulative score and availability. Ticket locations are most likely in the end zone or less desirable locations in each stadium. **For the 2009 season, ordering away game tickets or having received them in the past does not guarantee you will receive them.**
- 5 **Payment for away game tickets must be submitted prior to March 31st. Payment for away game tickets does not guarantee you will receive them.** Once away game tickets have been assigned, the Athletic Association will publish the cutoff scores in July. Contributors who ordered away game tickets but did not qualify will receive a refund check in the mail for their away game ticket payment. Contributors who were assigned away game tickets will receive them in the mail, prior to the start of the season, separate from season tickets.

Vanderbilt 2007: All Hartman Fund donors who ordered received tickets.

Georgia Tech 2007: Hartman Fund donors who ordered with a score of 25,501 and higher received tickets.

Florida Club 2008: Hartman Fund donors who ordered with a score of 42,500 and higher received tickets.

Georgia vs. Florida Game, Jacksonville, Florida

- 1 A benefit of contributing to the Hartman Fund is the opportunity to purchase Georgia vs. Florida game tickets. **You do not need to be a season ticket holder to qualify.** Hartman Fund donors are eligible to order based on their priority points and annual contribution.
- 2 Georgia will be the away team in 2009 and its seats will be on the east side of Jacksonville Municipal Stadium.
- 3 10,000 points are required to be eligible to order regular game tickets. 44,000 points are required to be eligible to order club seats. Ordering regular tickets does not guarantee you will receive them. **Ordering club seats does not guarantee you will receive them.** If you order club seats and do not qualify for club seats, you will be assigned the best available regular tickets based on your score and refunded the difference in the ticket price.

PARKING

- ✓ Parking is assigned based on availability and priority points.
- ✓ For the 2007 game, all Hartman Fund donors who qualified received a parking pass. **For the 2008 game, the cutoff score to receive parking was 25,400. Having a cumulative score above 25,400 does not guarantee you will receive parking for the 2009 game as the cumulative score necessary to receive parking changes each year based on availability and demand.**
